

**RULES AND REGULATIONS

1. Eligibility

1.1. The raffle is open to individuals who are 18 years of age or older.

2. Raffle Tickets

2.1. Tickets are available for purchase at \$118 each.

2.2. A tax receipt for \$80 will be issued for each full-priced ticket sold.

2.3. Tickets are available for sale from October 22, 2024, to November 20, 2024, at 7:45 PM, or until all tickets are sold.

2.4. A maximum of 1,400 tickets will be sold (#0001-1401).

2.5. Each ticket grants the purchaser one (1) entry into the raffle.

2.6. Tickets are non-refundable and non-transferable.

3. Raffle Prizes

3.1. Winners will be chosen through a random drawing of tickets, one by one, from a barrel.

3.2. A total of six (6) tickets will be drawn:

- 1st prize: \$180
- 2nd prize: \$180
- 3rd prize: \$360
- 4th prize: \$360
- 5th prize: \$1,800
- 6th and final grand prize: \$10,000

3.3. The total value of prizes to be won is \$12,880.

3.4. Chances of winning depend on the number of tickets sold during the Contest Period.

4. Draw Details

4.1. The raffle draw will take place on Wednesday, November 20, 2024, at 8:00 PM at 5400 Av. Westbury, Montreal, QC, H3W 2W8.

4.2. The winners will be selected randomly from all eligible ticket entries.

4.3. The winner does not need to be present at the draw to claim the prize.
